GUAM WORKFORCE DEVELOPMENT BOARD RESOLUTION NO. 2024-007

A RESOLUTION RELATIVE TO THE APPROVAL OF ELIGIBLE TRAINING PROVIDER LIST (ETPL) for PROGRAM YEARS 2025-2027

WHEREAS, Guam's Workforce Innovation and Opportunity Act (WIOA) 2024-2027 Combined State Plan was approved on January 16, 2025; and (June 26, 2024 first approval with conditions)

WHEREAS, the Guam Department of Labor (GDOL) is the administering entity of the Workforce Innovation and Opportunity Act (WIOA) funded programs as authorized by Guam Public Law 33-61; and as the lead agency, the GDOL is updating the Eligible Training Providers Listing (ETPL); and

WHEREAS, in accordance with Public Law 113-128, the Department shall identify eligible providers of training services in the local area available to participants as defined in Section 122, Identification of Eligible Providers of Training Services, Public Law 113-128 – July 22, 2014 Subtitle A – Workforce Innovations and Opportunity Act.

WHEREAS, the Governor of Guam shall make available training services to participants as defined in Section 122, Identification of Eligible Providers of Training Services, pursuant to WIOA Public Law 113-128 passed on January 3, 2014 and shall provide for biennial review and eligibility in accordance with Section 122 (c)(2), Identification of Eligible Providers of Training Services; and

WHEREAS, the selection of training providers is identified by the participant, the Department only facilitates the eligible training providers list that our participants are able to select their training providers.

WHEREAS, the U.S. Department of Labor, Employment and Training Administration, as guided in Training and Employment Guidance Letter (ETPL) 17-18, encourages states to integrate apprenticeship program opportunities and/or apprenticeship program sponsors into the Eligible Training Provider List approved for training assistance through WIOA to allow referrals to career seekers who register for training related services; and

WHEREAS, WIOA Section 185 requires each State, each local board, and each recipient receiving funds to monitor the performance of providers compliance with the terms of grants, contracts, or other agreements made pursuant to WIOA.

RESOLUTION

NOW, THEREFORE BE IT RESOLVED, the Guam Workforce Development Board (GWDB) adopts GWDB 2024-007, approving the Eligible Training Providers Listing for Program Years 2025 through 2027 and is subject to annual recertification on July 1, 2026.
