**Discussion before Old Business and after New Business**

**Mr. Claveria:**

**Needed more time to review compensation orders; Commissioner explained that the insurance carriers and the claimants meet and either agree or disagree on the awards if no agreement is made the carriers and/or claimants may acquire attorneys who in turn will do the negotiating for them, if no avail, then they may go to the WCC Board for ratification and/or formal hearing;**

**Commissioner empowered to be a sole hearing officer 22 GCA and 5 GCA 9220/21;**

**WC fund information, Annual Reports – Commissioner said that this was not the venue to discuss this topic but would be happy to meet with Mr. Claveria;**

**Compensation the WCC Board members;**

**Mr. Claveria wanted to make sure that the WCC Commission had all the documents re COAs.**

**Commissioner can hear and recommend judgment but this must be ratified by the WCC Board;**
